First Time Members

1st Year: 50% off dues

2nd year: 25% of dues applied to tab credit

3rd year: Full year membership

This is valid for all Family and Single Memberships

Family Membership

Family is defined as all immediate family members. Spouse and children up through college.

1st yr rate \$240 + \$90 capital

Dues rate equates to \$40 a month for unlimited golf and other club benefits (6 months = season)

2nd yr rate \$480* + \$90 capital, \$120 tab credit after dues paid in full

Dues rate equates to \$80 a month for unlimited golf and other club benefits. Plus a tab credit to utilize toward kitchen, bar or pro shop purchases.

3rd yr rate \$480* + \$90 capital

Single Membership

1st yr rate \$180 + \$60 capital

Dues rate equates to \$30 a month for unlimited golf and other club benefits (6 months = season)

2nd yr rate \$360* + \$60 capital, \$90 tab credit after dues paid in full

Dues rate equates to \$60 a month for unlimited golf and other club benefits. Plus a tab credit to utilize toward kitchen, bar or pro shop purchases.

3rd yr rate \$360* + \$90 capital

***2nd and 3rd year rates are subject to change. Example used is 2010 membership dues rates.**

Membership Dues are due May 1. Payment plans are available; please contact clubhouse.

Return Members

1st Year: 25% of dues applied to tab credit

2nd year: Full year membership

Past members who are returning after 3 years. Valid for Family and Single Memberships.

Family Membership

Family is defined as all immediate family members. Spouse and children up through college.

1st yr rate \$480 + \$90 capital, \$120 tab credit after dues paid in full

Dues rate equates to \$80 a month for unlimited golf and other club benefits (6 months = season). Plus a tab credit to utilize toward kitchen, bar or pro shop purchases.

2nd yr rate \$480* + \$90 capital

Single Membership

1st yr rate \$360* + \$60 capital, \$90 tab credit after dues paid in full

Dues rate equates to \$60 a month for unlimited golf and other club benefits. Plus a tab credit to utilize toward kitchen, bar or pro shop purchases.

2nd yr rate \$360* + \$90 capital

***2nd and 3rd year rates are subject to change. Example used is 2010 membership dues rates.**

Member Referral Program

Current Members who refer non-members to the course can qualify for a referral reward. Upon full payment of a new member's (first time or returning) dues and indication of current's referral, the current member will receive a \$50 tab credit.

Other Golf Course Rates:

Green fees:

9 holes = \$14

18 holes = \$20

Non-member, G.C. residents can attend 2 times a year

Cart fees:

9 holes = \$15

18 holes = \$28

Social Membership: Residents who don't golf, but would like clubhouse privileges.

\$65 per season

Student Membership: Students who do not belong under family membership.

Junior = \$80

College = \$180

Associate Membership: Non-local residents who hold a current membership with another club.

\$155 per season

Membership Dues are due May 1. Payment plans are available; please contact clubhouse.
